<p><b>1.Test Room</b> The tests shall be carried out in a room that has an air speed close to the appliance under test of <math>\leq 0.5</math> m/s. The ambient temperature shall be maintained at <math>70\text{ }^{\circ}\text{F} \pm 5.0\text{ }^{\circ}\text{F}</math>, <math>50\%\text{RH} \pm 5\%\text{RH}</math> throughout the test.</p> <p><b>2.Power supply</b> Where this standard is referenced by an external standard or regulation that specifies a test voltage and frequency, the test voltage and frequency so defined shall be used for all tests. Where the test voltage and frequency are not defined by an external standard, the test voltage and the test frequency shall be the nominal voltage and the nominal frequency of the country for which the measurement is being determined <math>\pm 1\%</math>.</p> <p><b>3. Supply voltage waveform</b> The total harmonic content of the supply voltage when supplying the appliance under test in the specified mode shall not exceed <math>2\%</math>; harmonic content is defined as the root-mean-square (r.m.s.) summation of the individual components using the fundamental as <math>100\%</math>.</p> <p><b>4. Power measurement accuracy</b> Precision measurement of energy consumption shall be made with a precision equal to the greater of <math>0.1</math> Watt-hour or <math>1\%</math> of full-scale measurement.</p>
